2018 Scholarship Fund

Eligibility:

Applicants who meet all of the following criteria are eligible for the scholarship. The applicant is:

- classified as a graduating high school senior in Texas **and/or** currently enrolled in college, vocational or trade school courses **or** applying to college, vocational or trade school at the time of application
- a policyholder, or child or grandchild of a Theiss Insurance Agency policyholder (policy must be in effect on or before March 26, 2018)
- has a current minimum GPA of 3.0 if current student (**Proof required**)
- Texas resident

(Note: Children or grandchildren of Selection Committee members are not eligible.)

Application Process:

Application materials must be received by 4 p.m. (CST) on April 20, 2018, in order to be considered. Applications may be emailed as an attachment (theissinsurance@gmail.com) or mailed/delivered in person to Theiss Insurance Agency (5202 Spring Cypress Rd. Spring, TX 77379). The following materials must be submitted:

1. Completed application (typed or hand-written; incomplete applications will not be considered)
2. Two letters of reference or recommendation from a teacher, coach, employer, or other adult who is not an immediate relative (section V of the application)
3. Proof of GPA if applicable

Selection Process:

Recipients will be selected by the selection committee based on application materials provided. All scholarship applicants will be notified of the committee's decision by May 11, 2018. Payment will be made to the recipient's choice of Texas institution upon notification.

Award:

There will be (2) one-time scholarships awarded, each for \$500 to be used for the recipient's educational expenses. Eligible applicants may not receive more than one scholarship, or \$500, from the Theiss Insurance Agency Scholarship Fund **per year**.
